
Subject: Affiliation of Units/Trades of Govt./Pvt. ITIs with NCVT-regarding

It may please be noted, that the cases wherein clarification is sought, reply should reach immediately to DGE&T (HQ) New Delhi so that they can be considered in the next meeting.




