TO HOLD/CONDUCT PRIVATE VOLUNTARY TRAINING**

Sir,

1. The powers so exercised by quality Councils of India (QCI), functioned in 2002, under the provisions of the State Committee of Vocational Councils for Vocational Training (SCVVT) Deemed to be unconstitutional and illegal.
2. The State Committee exercised affiliation, grants and audited approval for the private training in the SCVVT norms. In per the last document known,

 3. The affiliation of the Training centre stated above;
 4. It should be periodic affiliation;
 5. The ITI should comply with SCVVT norms/guidelines issued from time to time;
 6. ITI should display the newly processed logo of ITI on the Display Board at the centre.
 7. The existing ITI is required to submit Building-compliance certificate (BCC) before starting admission or no subsequent admission, if one submitted already.

8. The said information is the opinion of DGT while India.
9. In case of any discrepancy observed in the affiliation norms, same may be informed to Headquarters QCI.
