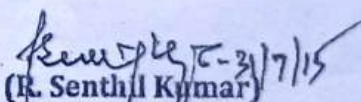
Sir

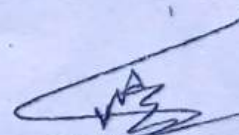
