The Committee considered affiliation proposals and accorded approval to proposals conforming to the NCVT Norms. Part-I of Affiliation orders, State wise, were issued & Part II of these affiliation orders was to be issued upto 31st August 2015.


In continuation to above, Affiliation Orders-Part II, have been issued & enclosed for information. These cases cover clarifications cases of previous meetings i.e. 23rd June, 30th July & 25th August, 2015, any other cases included in the Agenda of the meeting dated 25th August, 2015, & those received from QCI after accreditation. The orders are also uploaded on the website dget.gov.in.

In this regard the following points may be noted:

- This supersedes any other earlier clarification order issued in previous meeting with reference to current session i.e. August 2015.
- All those cases cleared up to the NCVT Sub-Committee meeting dated 30th July, 2015 would not get any extension in admissions beyond 31st August, 2015.
- The affiliation orders issued vide letter dated 25th August 2015 and later, for the session August 2015 would get extension for admitting trainees upto 17th September 2015.
