

In this regard the following points may be noted:

- > This supersedes any other earlier clarification order issued in previous meeting with reference to current session i.e. August 2015.
- > All those cases cleared up to the NCVT Sub-Committee meeting dated 30<sup>th</sup> July, 2015 would not get any extension in admissions beyond 31<sup>st</sup> August, 2015.
- > The affiliation orders issued vide letter dated 25<sup>th</sup> August 2015 and later, for the session August 2015 would get extension for admitting trainees upto 17<sup>th</sup> September 2015.
