 - Periodic verification. (i)
 - The ITI must comply with NCVT norms/guidelines issued from time to time. (ii)
 - ITI must display the newly released logo of ITI on the Display Board at the main gate. (iii)
 - The existing ITI is required to submit Building Completion Certificate (BCC) before (iv) admitting trainees in the August 2017 session, if not submitted already.


