As decided in the 24th meeting of the Standing Committee on Accreditation and Affiliation (SCAA) held on 22.09.2025, the recommendations for trades and units of ITIs, effective from the academic session 2025, are enclosed herewith.

2. The recommendations contained in the enclosed list shall be read in conjunction with the minutes of the 24th SCAA meeting.

3. Further, the Competent Authority has also decided to extend the admission cut-off date by 15 days, i.e., up to **15th October 2025**, exclusively for ITIs granted affiliation in the 24th SCAA meeting held on 22.09.2025.

4. The affiliation of trades/units is subject to the following conditions:

- Officers of DGT and the State Directorate can inspect the ITI at any time to ensure effective training and performance.
- Periodic verification of compliance shall be undertaken.
- The ITI shall comply with all DGT norms and guidelines issued from time to time.
- The ITI shall display its name and logo prominently on the display board at the main gate.
