
Subject: Affiliation of Units/Trades after conversion from SCVT to NCVT.

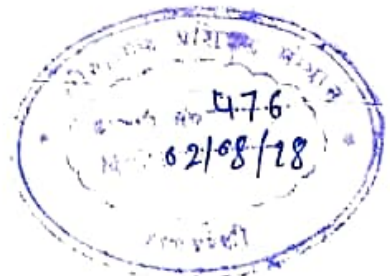


